This is also a good time to remind everyone that parking with your vehicle hanging over the sidewalk creates an unnecessary obstacle for the staff who are working on clearing the sidewalks and may result in an Administrative Enforcement Fee being added to your account.

#### An Open Letter Regarding Marijuana Usage at Hanover Grove

**Dear Members:** 

If you are not aware, Hanover Grove Cooperative was constructed pursuant to a housing program initiated by Congress. As a result, the Cooperative entered into agreements which required it to be governed by the Department of Housing and Urban Development (HUD). This agreement required the Cooperative to adhere to regulations of the Federal Government as it relates to housing.

One of the primary directives from HUD is that the <u>Cooperative must remain drug free, which includes all illegal drugs, including marijuana.</u> When the Cooperative adopted its Rules and Regulations and Occupancy Agreement it included prohibitions against such drug use.

Therefore, by the Cooperative documents and Federal Law, members of Hanover Grove Cooperative are forbidden from the use of any illicit drug as defined by Federal Law. Further, the Rules and Regulations and your Occupancy Agreement requires that the Cooperative provide each member peaceful enjoyment of their townhome.

Each member must refrain from actions which deny other members peaceable enjoyment of their townhome. Loud noises such as blaring TV's or sound systems, late night parties, and vacuuming after 10:00 p.m. are examples of denying your right to peaceable enjoyment. Smoking marijuana is another example because of the strong smell which permeates through the walls and subjects your neighbors and their children to this nuisance denying them peaceable enjoyment.

Recently, the State of Michigan enacted a series of new laws which modify the use and enable restrictions on the use of marijuana. A section of that law, MCL 333.26427(c)(3) states that the owner (Cooperative) can prevent the smoking or cultivation of marijuana. Therefore, despite the fact that you may have a medical marijuana card authorizing the use, you are prohibited from smoking marijuana at the Cooperative for the two reasons set forth; 1) restriction imposed by HUD regarding illicit drugs as defined by Federal Law, and 2) the State law prohibiting its use in a multi-family environment.

Although the Cooperative cannot endorse the use of medical marijuana due to Federal law, for those who have the medical need for its use, there are many other products available that will not adversely affect your neighbors.

This letter should serve as notice that the Cooperative will aggressively enforce the restriction of the use of illicit drugs, including smoking marijuana in any form. Such use may result in the possible loss of your membership and eviction.

#### SECTION 107 - VEHICLES, PARKING & DRIVING REGULATIONS

During the winter months, residents must move their vehicles as necessary for snow removal by the Maintenance Department. The following schedule has been determined for snow removal from parking areas. The drivers of the trucks plowing the snow will honk their horns to notify you that they are attempting to plow your parking area.

#### YOUR COOPERATION IS REQUIRED.

- 107.11(a) Members living in **even** addresses (i.e., 31008, 15608, etc.) will have their parking areas plowed between 9:00 am and 12:00 NOON. All cars must be removed from the parking areas before 9:00 a.m.
- 107.11(b) Members living in **odd** addresses (i.e. 31125, 15819, etc.) will have their parking areas plowed between 1:00 pm and 5:00 pm. All cars must be removed from the parking areas before 1:00 p.m.
- 107.11(c) The only exceptions to this rule will be those areas of Darby Lane and Van Avenue that have parking on one side of the street only and the Courts that comprise the 900 blocks of Darby, Sabre, and Van. These parking areas will be plowed in the afternoon, between 1:00 pm and 5:00 pm with the odd addresses.
- Residents not moving their cars during the appropriate time periods for snow removal may have their vehicles towed away at the owner's expense and receive a \$50.00 Administrative Enforcement Fee.
- Residents or their guests having inoperable vehicles in the parking areas during snow removal will also be subject to having their vehicles towed away at the owner's expense and receive a \$50.00 Administrative Enforcement fee.

#### ATTENTION RESIDENTS

If you do not have a Hanover Grove parking decal in your rear window and you have not complied with the above rules we will have no way to notify you and you will be towed away at your expense!



## **RECIPES**



#### **Snowman Cheeseball**



Prep: 5-10 Minutes

Cook: 20-25 Minutes

Total: 30-35 Minutes



Prep: 25 Minutes

Make Time: 12 Minutes

Total Time: 37 Minutes

## Ingredients

- 28 oz blocks of cream cheese at room temperature
- 3 1/2 cups shredded sharp cheddar cheese at room temperature
- 1 oz package ranch seasoning mix
- 1 1/2 cups finely shredded jack cheese
- 1 baby carrot
- Whole peppercorns

#### **Directions**

- 1. Let cream cheese and shredded cheddar come to room temp. In the stand mixer fitted with paddle attachment, combine cream cheese, shredded cheddar cheese, and ranch dressing mix.
- 2. Divide cheese mixture and form one smaller cheese ball and one larger cheese ball. Transfer cheese mixes to two separate sheets of plastic wrap. Refrigerate for at least 4 hours, or overnight. (Can be made to serve several days ahead.)
- 3. Right before serving, press shredded cheese onto cheeseball. Place on a serving plate and place the smaller cheese ball on top of the larger cheese ball. Slice the tip off a baby carrot and press into cheeseball to make the nose. Use whole peppercorns for mouth, eyes, and buttons. Serve with crackers.
- 4. Enjoy!

### **Candy Cane Cookies**

## Ingredients

- 1 box sugar cookie mix
- 1/2 stick butter, melted
- 1 egg
- 1/3 cup softened cream cheese
- 1/2 cup all-purpose flour, plus additional for surface
- Red food coloring
- 1 1/2 teaspoons peppermint extract

#### **Directions**

- 1. Preheat oven to 325 degrees F.
- 2. In a bowl, combine sugar cookie mix, melted butter, egg, cream cheese, and flour; mix together to form dough. Separate dough into 2 equal portions and place in 2 different bowls. Add red food coloring gradually to 1 bowl of dough, kneading together until desired shade of red is created. To second bowl of uncolored dough, add peppermint extract and knead together. On a floured work surface, shape each dough into balls and then roll each ball into 1/4-inch-wide ropes, each about 6 inches long. For each cookie, carefully twist some of the red and white ropes of dough together and shape into a candy cane. Spread candy canes out on cookie sheets and bake on the top shelf of the oven for about 10 to 12 minutes. Transfer to a rack to cool before serving.
